## Product Structure

The Kick-In GOAL worst-of style with Participation is a product that provides a fixed coupon and the redemption is linked to the performance of the Underlyings.

As long as the Kick-In Levels have never been touched or breached during the lifetime of the product, Investors will receive the greater of 100% of the Nominal or the Basket Performance in cash. Otherwise, Investors will receive

- 100% of the Nominal in cash, if at Expiry all Underlyings close at or above the respective Strike Level; or
- the worst performing Underlying, taking into account the relevant Conversion ratio, if at Expiry one or more Underlyings close below the Strike Level.

The coupon will be paid out in any scenario. The Product offers a relatively high coupon as well as full upside participation in the Basket Performance as long as no Kick-In Event occurred. In return for that, Investors are taking the risk of a loss equivalent to a direct investment in the worst performing Underlying.
