Otherwise, the Investor will receive a cash settlement corresponding to the Expiration Value of the Underlying on the Redemption Date, taking into account the Conversion Ratio.

The downside risk of a Capped PERLES Plus is similar to that of the Underlying, i.e. the investor could lose his total investment if the Underlying value falls to zero. The maximum redemption value is limited at the Cap Level.
