The Kick-In Certificate with Early Redemption Feature is a product that offers an attractive return if on any Observation Date the Underlying closes at or above a predefined Bonus Level. In this case the Investor will receive a fixed Bonus payment for this period. Coupon Payments that were missed in earlier periods may be caught up provided that all Underlyings close at or above the Coupon Level on any subsequent Observation Date.

Should the Underlying close at or above a predefined Early Redemption Level on any Observation Date, the product will redeem early.

If no such event occurs, the Investor will still receive 100% of the Nominal on the Redemption Date provided that no Kick-In Event has occurred.
