## Product Structure

The Open End Turbo Put Warrant allows investors to profit from the downward (bearish) trend of an Underlying. The Open End Turbo Put Warrant moves approximately 1 unit of currency up, if the Underlying moves 1 unit of currency down and vice versa taking into account the conversion ratio and the adjustments of the Strike / Knock-Out Barrier. The risk of loss is limited to the invested capital.

If the value of the Underlying at any time during the product life time lies at or above the Current Knock-Out Barrier, the Open End Turbo Put Warrant expires immediately and worthless.

The Current Knock-Out Barrier is always equal to the Current Strike.
