$\min(\text{Underlying price at 12:00 CET on Expiration Date; Settlement Price}) - \text{Strike}$ , adjusted for the Conversion Ratio and converted into the Redemption Currency, if applicable.

For the avoidance of doubts, if either the Underlying price at 12:00 CET on the Expiration Date or the Settlement Price are equal or below the Strike, no payment will be made.
