Product Structure

The GOAL worst-of style with Early Redemption at the Issuer's choice is a product that provides a fixed coupon and the redemption is linked to the performance of the worst performing Underlying.

As long as no Early Redemption Event has occurred and all Underlyings close above the respective Kick-In Level at Expiry, the Investor will in any event receive 100% of the Nominal in cash. Otherwise, the Investor will receive a value reflecting the performance of the worst performing Underlying taking into account the Conversion Ratio.

The Coupon will be paid out in any scenario. The Product offers a relatively high coupon in return for not profiting from a potential positive performance of the Underlyings and for taking the risk of a loss potential equivalent to a direct investment in the worst performing.
