Product Structure

The Airbag Certificate is a product which tracks the performance of the Underlying with the possibility to leverage the performance in a given range while limiting the upside.

If the Underlying closes above the Lower Strike Level, the Investor benefits from a leveraged payout up to the Cap Level, which means, however, that the maximum return is limited. If the Underlying closes below the Lower Strike Level, the Investor will receive the respective closing value taking into account the gearing and is therefore fully exposed to the downside risk.
