The Bearish Dolphin CPN enables the Investor to get 97% plus the absolute value of the negative performance if no barrier event has occurred and if the Expiration Value of the Underlying is below the Strike Level. If the Expiration Value of the Underlying is at or above the Strike Level, the investor receives at Redemption 97% of the Nominal. If the Underlying ever trades at or below the Barrier, the investor receives at Redemption 97% of the Nominal plus the Rebate. The minimum repayment at maturity will be the Capital Protection.
